Application:

Specially developed agent for cleaning tile joints on walls and floors. Removes grease, rust and scale deposits, water stains and other stubborn dirt. Effective both indoors and outdoors.

Storage:

Shelf life up to 24 months from the production date.

Store in dry and well-ventilated rooms.

Storage and transport temperature: from + 5 ° C to + 25 ° C. The product must be protected against freezing.

Packaging: Black bottle 500 ml with a white and red foaming atomizer.

Directions for use:

Use the product undiluted. Taking all precautions, apply the preparation on the joints with an atomizer. Wait about 5 minutes for the agent to take effect. The joints should be cleaned with a brush or sponge. After cleaning, thoroughly remove all agent residues with a damp sponge. In the case of particularly stubborn dirt, the operation should be repeated. Allow the binder to dry after cleaning.

Health and safety warnings and recommendations:

When using the product, the basic principles of occupational health and safety should be followed. Protect the preparation from children. Irritating product. Irritating to eyes, respiratory system and skin. When using the preparation, use personal protective equipment such as protective clothing and gloves, glasses, and, if necessary (e.g. in conditions of insufficient ventilation), also respiratory protection apparatus. Use the product only in well-ventilated areas. During use and immediately after handling the product, wash your hands thoroughly with soap and water. In use do not eat, drink or smoke the product.

Wash contaminated clothing before re-wearing. If swallowed, give plenty of water to drink. Water administration should be discontinued if nausea appears. Do not induce vomiting.
