APPLICATION.

Desolver PRO is a preparation intended for removing concrete and cement residues from excavators, concrete pumps, tractors, drills, concrete mixers, and can also be used to remove impurities, dirt and deposits from all types of cement and lime mortars, rust stains, limestone, etc. It can be used on ceramic and stone tiles, burnt bricks, chrome, varnished, stainless steel and plastic surfaces. Desolver PRO is suitable for cleaning surfaces of newly constructed buildings and production halls, as well as after renovation.

HOW TO USE

The preparation should be applied to the surface to be cleaned:

- in case of heavy and old dirt, wait a few minutes, if necessary, support the process mechanically, then rinse thoroughly with water. It is best to use a brush or a sharp sponge to apply the product and remove dirt;
- when cleaning construction equipment from fresh concrete, a Karcher type high-pressure pump should be used.

Depending on the substrate and the intensity and type of dirt, the agent should be used undiluted or as a mixture with water according to the instructions in the table:

In undiluted form	Thick layers and permanent deposits from cement mortars
1 part of the preparation: 3-5 parts of water	Cement and cement mortar remains
1 part of the preparation: 5-10 parts of water	Lime mortar residues, salt efflorescence and flat concrete residues on construction equipment
1 part of the preparation: 10-15 parts of water	Rust and water stains (limestone)

Before applying the agent, it is recommended to perform a cleaning test. Clean tools with clean water immediately after use.

Plastic bottles and canisters with a capacity of 1 l, 5 l, 10 l, 20 l or other upon agreement with the customer.

STORAGE AND TRANSPORT.

The product should be transported and stored in tightly closed, original packaging at temperatures from +5 °C to +25 °C. Protect from moisture, frost and sunlight. Close tightly after opening. Shelf life 24 months from the production date placed on the packaging.

SECURITY.

Skin Corr. 1B – contains phosphoric acid.

Wear protective gloves/protective clothing/eye protection/face protection.

IF ON SKIN (or hair): Remove/Take off immediately all contaminated clothing. Rinse skin with water/shower.

IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing.

Store locked up.
