APPLICATION.

GUARDBET is a water-based polymeric concrete protection agent that gives it a deep-toned look. Produced on the basis of modified polymers, it creates a transparent, water-resistant film. It creates an ideal base for care emulsions, applied as a covering or abrasive layer.

HOW TO USE

- **Preparation of the substrate:** The protected surface should be carefully cleaned of dust, dirt, and fragments that are poorly bonded to the substrate. New substrates must be dry, seasoned, degreased, and free of formwork.
- **Preparation of the agent:** GUARDBET is sold ready for direct application.
- **Application and drying:** The preparation should be applied **EVENLY** (without leaving puddles) using a brush, paint roller or spray at an ambient temperature of +5°C to +30°C. In the case of very absorbent substrates, the procedure should be repeated after drying, i.e. usually after approx. 4 hours. Drying time depends on the humidity and temperature of the air and substrate. Fresh coatings should be protected from moisture and frost.

Wear	From 0.05 to 0.2 L per 1 m ² (depending on the absorbency of the substrate)

Ambient, preparation and substrate temperature	From +5°C to +30°C

PACKAGING.

Plastic bottles and canisters with a capacity of 1 l, 5 l, 10 l, 20 l or other upon agreement with the customer.

STORAGE AND TRANSPORT.

Transport and store in tightly closed manufacturer's packaging at a temperature of +5°C to +30°C, in a place not exposed to sunlight. Shelf life 24 months from the date of production.

SECURITY.

May cause an allergic skin reaction.

Keep out of reach of children.

Avoid breathing dust/fume/gas/mist/vapours/spray.

Wear protective gloves/protective clothing/eye protection/face protection.

IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Store locked up.
