APPLICATION.

GUARDBRUK is a professional agent for the maintenance and protection of paving stones, old pavements and concrete elements. The preparation perfectly protects the surface, highlights its color and protects the color from fading. GUARDBRUK has excellent resistance to alkalis, high adhesion to any type of substrate and high resistance to abrasion.

HOW TO USE

- **Preparation of the substrate:** The substrate should be suitably strong, degreased and cleaned of dust, dirt, lime, stains and biological efflorescence (for degreasing and removing dirt, the manufacturer recommends a product called Desolver PRO, Desolver Klinkier PRO or Polisol PRO). The entire surface intended for application must be thoroughly dried. Surfaces made of fresh paving stones should be impregnated only after 2-3 weeks from installation.
- **Preparation of the agent:** GUARDBRUK is sold ready for direct application. In the case of less absorbent substrates, the preparation can be diluted with water in the ratio of 1 part preparation to 3 parts water.
- **Application and drying:** Apply the preparation with a brush, paint roller or spray at an ambient temperature of $+5^{\circ}$ C to $+30^{\circ}$ C. It is recommended to apply two layers, the second layer should be applied before the previous one dries. The preparation can also be used for impregnation by immersion. To do this, dilute it with water in the following ratio: 1 part of the preparation to 4.5 parts of water.

PACKAGING.

Plastic bottles and canisters with a capacity of 1 l, 5 l, 10 l, 20 l or other upon agreement with the customer.

STORAGE AND TRANSPORT.

Transport and store in tightly closed manufacturer's packaging at a temperature of +5°C to +30°C, in a place not exposed to sunlight. Shelf life 24 months from the date of production.

SECURITY.

Avoid breathing dust/fume/gas/mist/vapours/spray.

Wear protective gloves/protective clothing/eye protection/face protection.
