Preparation for the daily care of bathroom fittings and ceramics. Especially recommended for cleaning matt chrome, satin, full gloss and PVD coated surfaces. Removes sediments and traces of water, stone, toothpaste, cosmetics, etc. Perfectly cleans ceramic sinks and countertops. Leaves a fast drying protective film without streaks.

Directions for use:

Observing all precautions, apply the preparation with an atomizer on the surface to be cleaned. Leave for a while (about 1 minute), then wipe with a wet cloth. Rinse the cleaned surface with water. Allow to dry or gently wipe dry.
