# Application:

Professional preparation with the addition of improvers for removing strong and stubborn dirt on all washable surfaces. Easily and effectively dissolves greasy, old and crusted kitchen deposits and prevents re-deposition of dirt. Cleans without scrubbing or scratching.

## Packaging:

Black bottle 250 ml, 500 ml with an atomizer.

#### **Directions for use:**

Observing all precautions, use an atomizer to apply the preparation on the dirty surface. Evenly spread it with a sponge or cloth. Wait a few seconds. The entire surface should be rinsed thoroughly with water. Repeat rinsing with water until the foam residues of the product are completely removed. After rinsing, wipe the surface dry.

#### Health and safety warnings and recommendations:

When using the product, observe the basic health and safety regulations. Do not eat or drink during use and immediately after use and do not smoke. Immediately after using the preparation, wash your hands thoroughly with soap and water.

When using the product, always use personal protective equipment, such as: gloves, clothing and safety glasses. Use the preparation only in well-ventilated rooms. Do not inhale the spray. Avoid eye contamination. Protect the preparation from children. The product is irritating to the skin. Causes serious eye damage.
